3. Following application for membership, the name(s) and photograph of prospective members shall be published in the club newsletter or by email.

4. After allowing ten (10) days for comments from the general membership, approval of the application shall require 2/3 favorable vote of the Governing Board.

5. It shall be the responsibility of the Governing Board to notify the applicant(s) of the disposition of the application for membership in the Club.
